

Abortion in the United States was heavily restricted before the fall of Roe


No. of restrictions enacted per year, as of June 21, 2022

Abortion care landscape before Dobbs (2020)







- Produce "live," publicly available estimates of state-level abortion incidence monthly
- Recruit monthly samples of abortion providers to collect info on:
 - Number of abortions provided, by month
 - Patient state of residence
 - Gestational age
 - One other rotating policy relevant question
- Combine sample data with Guttmacher's wealth of historical facility-level data in a Bayesian model to produce iteratively updated national and state estimates




Estimated number of clinician-provided abortions in states without total bans, 1973-2023





Travel across state lines




Proportion of patients crossing state lines

Number of patients crossing state lines





What these data don't capture

- People at later gestational ages have far fewer options for care, and likely travel much farther (e.g. 16+ weeks gestation)
- Who is able to travel: Requires enormous amounts of resources, and adolescents in particular face additional barriers
- How travel patterns have shifted post-Florida ban, and as funding landscape gets more difficult



Number of abortions



Expanding access through new care delivery models

- Telehealth provision, including through shield laws, provides critical access to abortion care.
- In the first quarter of 2024, #WeCount found that:
 - 20% of abortions were provided through telehealth
 - 19,700 telehealth abortions per month, including virtual-only clinics, brick-and-mortar clinics, and shield law providers














Monthly online medication abortion *requests* in the US after Dobbs

Survey of online medication abortion users

- Data on treatment seeking behaviors, health care needs, support and satisfaction
- Florida (pre/post ban), Indiana (pre/post ban), and Louisiana (post ban)
 - Round 1: May December 2023
 - Round 2: May August 2024
- Recruited participants via eleven providers listed on Plan C, including online clinics, community networks and websites selling pills.
- N=441 (data collection ongoing)
- Survey of online medication abortion providers



Where are we now?

- Fractured policy landscape
- More abortions occurring after Dobbs, driven by
 - 1. Expanded capacity in states without bans
 - 2. Financial and logistical support for travel
 - 3. Expansion of telemedicine services, including shield law provision
- Many other people are accessing medication abortion through online providers, and receiving a high level of support and information
- But healthcare needs remain for people using these services, particularly in states with bans
