# My Body My Life

Real stories of abortion, is a multimedia travelling exhibition, first shown at the 2017 Edinburgh Fringe Festival. While one in three women in the UK will have an abortion at some point in their lives, research has shown that abortion is still highly stigmatised and shrouded in secrecy. The silence surrounding abortion can lead to stigma, generate shame, isolation and self-blame. To address this, we developed http://mybody-mylife.org/ as a travelling story-telling exhibition that allows people to share their personal stories about abortion. Designed by The Liminal Space, the exhibition is research-based, and coproduced by academics, abortion providers, sexual health professionals and activists. It has already taken positive steps to challenge abortion stigma, making a space where abortion is normalised and discussed openly. The exhibition shares women's stories in their own words — their experiences, their emotions and their decisions. This exhibition also enables anyone affected by abortion to contribute their story (anonymously) to the exhibition stands, and to the associated website.
