The start of Pregnancy in Abortion Law is a "legal fiction"

"Legal fiction refers to a fictitious fact that is treated as true under the law for purposes of legal, administrative or other expediency."

An upper time limit in Abortion Law is a "legal fiction"

But with severe practical consequences for a women in need of treatment

? "the pregnancy has not exceeded its twenty-fourth week" ?

In the UK, "all elements of abortion treatment must be completed by...."

22 July 2018 = 24 weeks + 0 days

23 July 2018 = 23 weeks + 6 days



What a difference a day makes!
